OLD BUSINESS

State Buffer Program

District Administrator Mell reviewed with the Board the April 3, 2017, BWSR Common Alternative Practices guidance document. This technical document provides an overview of the process and considerations conducted by Soil and Water Conservation Districts when assisting landowners in implementing the Alternative Practices provision in the Minnesota Buffer Law. Additionally, this document details a "6 pack" of

common alternative practices that may be a useful start for landowners interested in water quality protection options comparable to a buffer and to SWCDs in offering alternative practices implementation support and validation. No Board action was taken.

State Buffer Program - Local Water Resource Riparian Protection
