Resolution No. 2023-08-01 A Resolution Establishing the Chisago SWCD Roland Cleveland Cost Share Program

WHEREAS, Roland "Rollie" Cleveland served Chisago County as a Supervisor of the Soil and Water Conservation District from July 9, 1987, until his passing on June 8, 2023; and

WHEREAS, during his nearly 36 years as a SWCD Supervisor, Rollie became a great and humble champion for conservation at the local, area and state level; and

WHEREAS, on December, 3, 2012, Rollie received the Minnesota Association of Soil and Water Conservation Districts (MASWCD) Outstanding SWCD Supervisor Award for his outstanding leadership not only to the Chisago SWCD, but to his Area and to the State Association through representation on numerous committees and policy teams; and

WHEREAS, on December 10, 2018, Rollie was elected the President of the MASWCD for 2019 and 2020; and

WHEREAS, Rollie was a great partner, voice for conservation and a good friend to all that met him; and

WHEREAS, the Chisago SWCD Board of Supervisors wishes to express its sincere thanks and appreciation for Rollie's dedication and outstanding performance of his duties during his nearly 36 years as a Supervisor.

THEREFORE, BE IT RESOLVED that the Chisago Soil and Water District Board of Supervisors establishes the Roland Cleveland Cost Share Program to be utilized as a local funding source to implement conservation programs and practices throughout Chisago County; and

BE IT FURTHER RESOLVED that the Chisago Soil and Water District Board of Supervisors designates \$20,000 of the SWCD reserve funds to the Roland Cleveland Cost Share Program; and

BE IT FURTHER RESOLVED that the Chisago SWCD Board will annually designate additional funds if available towards the Roland Cleveland Cost Share Program to implement conservation programs throughout Chisago County in honor of Roland "Rollie" Cleveland.

BWSR FY23 Clean Water Fund Grant Application
