#### Lower St. Croix Watershed Partnership

Motion by Birkholz and seconded by Tollberg to approve the Lower St. Croix Watershed Partnership 2024 Annual Plan of Work. Motion carried.

#### **Partner Contracts**

Motion by Wilson and seconded by Cedergren to approve the Professional/Technical Services Contract (Contract #2024-1) for up to \$75,000 by and between Chisago County on behalf of the Chisago Lakes Lake Improvement District and the Chisago Soil and Water Conservation District. Motion carried.

Motion by Tollberg and seconded by Wilson to authorize District Administrator Mell to finalize an agreement with the Washington Conservation District for up to \$20,000 for Engineering assistance provided by the Washington Conservation District to the Chisago SWCD. Motion carried.

#### **BWSR Soil Health Grant**

Administrator Mell updated the Board on the upcoming BWSR Soil Health Grant program and discussed the potential for a shared staff person with other members of the Lower St. Croix Watershed

Partnership. The Board consensus was supportive of Administrator Mell to work with neighboring SWCDs to apply for BWSR Soil Health Grant funds for both technical assistance and implementation funds. No Board action taken at this time.

# **SWCD Planning Session**

The Board discussed the increased funding opportunities for SWCDs and the need for a long-range planning session. The consensus of the Board was for Administrator Mell to explore options for an outside facilitator to work with our SWCD on a long-range planning workshop. No Board action taken at this time.
